Sample Notary Public Statements - Pennsylvania A notary public or other officer completing this certificate verifies only the identity of the individual who signed the document to which this certificate is attached, and not the truthfulness, accuracy, or validity of that document. Certificate of Acknowledgments Notary Public, the signer must be positively identified by the Notary Public and the signer must acknowledge having willingly signed the document.
